

Novel Coronavirus (COVID-19) (11/20/2020)

The Town of Bow Emergency Management Team continued to monitor this situation and is in regular communications with our fire and ems, police, elected officials, SAU, and state counterparts and will continue to monitor the situation and respond accordingly.

The EOC continues to operate from 0800 to 1600 hours (M-F), at the Enhanced Monitoring Level (Limited Staffing). The EMD COVID-19 Summary Reports have been reduced in frequency to once a week. Bow Schools are operating at various levels of instruction. The level status for Bow SAU 67 schools for November 23rd and 24th will be as follows: Monday November 23 - BES in RED (Full Closure). Tuesday November 24 - BES in ORANGE (All-Remote) for grades 1-4, Kindergarten in RED. BMS and BHS will remain in Yellow (50% in person), for November 23 and 24. No school the 25th thru 27th.

Instead of the Annual Tree Lighting Event this year, the Town of Bow will have a Christmas Parade with Santa Claus, much like the Birthday and Graduation Parades that were organized this past spring and summer will be held Sunday November 29th. The Parade will leave Bow High School at 3:00 pm, taking a left onto White Rock Hill Road and then a right onto Bow Center Road following a large loop around the Town of Bow and ending back at the High School.

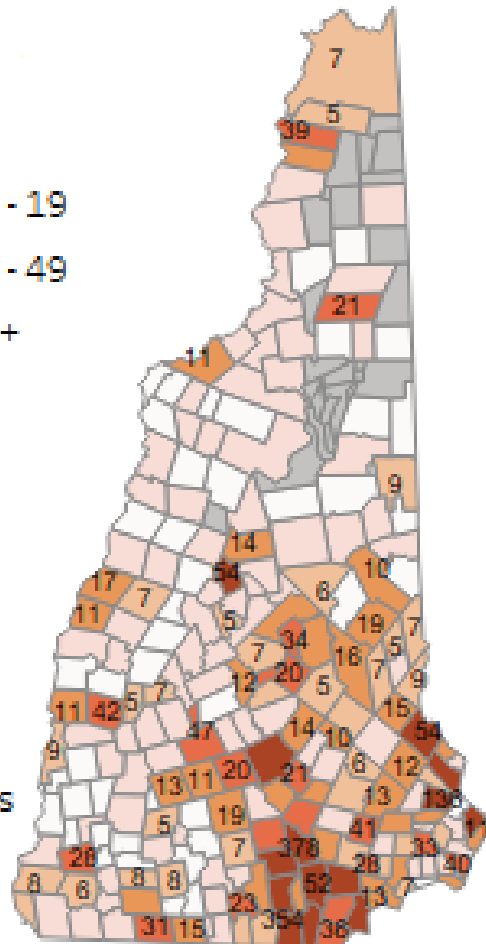
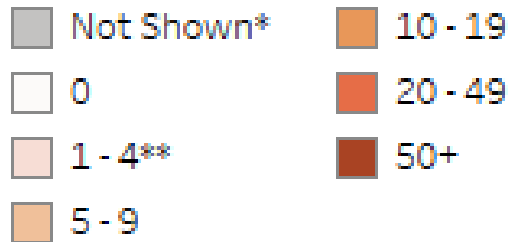
