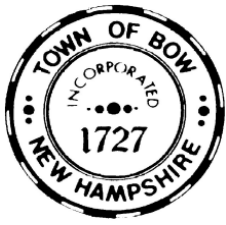

1. **Application no. 203-08: GSP Merrimack** – Minor Site Plan Modification to terminate requirements for reporting and stormwater testing related to a gypsum surge pile.
Located at 413 River Road; Map 41, Block 2, Lot 200; Zone: General Industrial (I-2)
2. **Application no. 209-24: Hoptimystic Brewing** – Minor Site Plan Modification to adjust number and location of structures for Phase 1.
Located at 516 South Street; Map 11, Block 1, Lot 32; Zone: Bow Mills Mixed Use (BMM)
3. **Kearsarge Energy** – Conceptual Consultation for Bow landfill solar facility.
Located on Falcon Way; Map 14, Block 4, Lots 65 & 71; Zone: Civic (CV).
