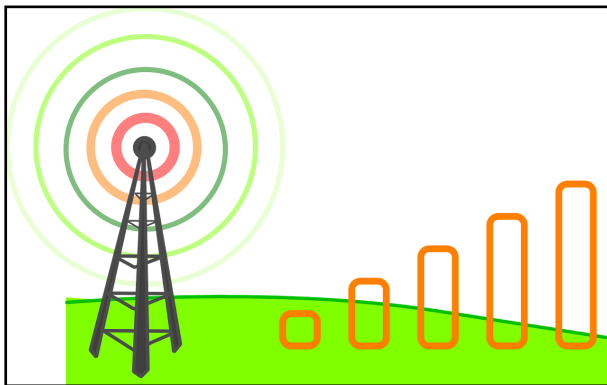

The filing period for candidates for Town and School Offices began on Wednesday, January 19 and ends on Friday, January 28. Candidates may file their declaration of candidacy at the Town Clerk's Office at the Bow Municipal Building, 10 Grandview Road.

Info on Petitioned Warrant Articles



Did you know that voters have the right to add Articles to the Town Meeting Warrant by petitioning the Board of Selectmen?

The petition must be signed by 25 or more voters, or 2 percent of the registered voters in town, whichever is less, but not fewer than 10 registered voters. (RSA 39:3).

The Selectmen must insert any article submitted to them, as long as it has the required number of signatures and meets the submittal deadline.

EXCEPTION: Petitions for Zoning or Building Code amendments have to be submitted at least 90 days before the annual meeting (RSA 675:4) and need 25 signatures instead of just 10.]
