COVID-19 VIRUS
BUSINESS MEETING PROCEDURES
(BASED ON CURRENT CDC GUIDANCE AND STATE OF NEW HAMPSHIRE
UNIVERSAL BEST PRACTICES)
TOWN MEETING: March 9, 2022
SCHOOL MEETING: MARCH 11, 2022**

1. All persons will be encouraged, but not required, to wear a mask in the Business Meetings for the health and safety of all. Masks will be provided to those who wish to wear one.
2. Meeting workers and officials will be protected by table screens or other barriers, if they so wish.
3. Registered voters will enter the Bow High School using separate lines broken down by letters of the alphabet.
4. Voters will participate in the meeting either in-person in the Bow High School Auditorium, or in the Cafeteria and Gym, if required. Voters who sit in the Cafeteria or Gym will have a YouTube-style video and audio link to the Auditorium, and will be able to speak to the whole meeting using a microphone and camera in the "Multi-Purpose Room" (sometimes called the "Small Gym").
5. The Auditorium will be designated as a mask-optional room.
6. The Gym will be reserved solely for those who wish to wear masks and maintain social distancing, and do not want to sit with those who are unmasked.
7. If you are a Business Meeting worker or official and cannot make each of the following statements (based on CDC Guidelines), please do not attend the Business Meeting. If you are a voter, and cannot make each of the following statements, we encourage you not to attend the Business Meeting for the health and safety of all, but if you insist on attending, please let the Moderator know before entering the Bow High School:
 - I have not tested positive for COVID-19 during the past 5 days.
 - If I tested positive for COVID-19 between 5-10 days ago, I have no symptoms or my symptoms are resolving and I will wear a mask at all times in the Business Meeting.
 - If I was exposed to someone with COVID-19 during the past 10 days, but I have (a) completed the primary series of a CDC-approved COVID-19 vaccine and received a booster shot, and (b) I have not developed any COVID-19 symptoms, then I will wear a mask at all times in the Business Meeting.
 - If I am either (a) not vaccinated, or (b) I have not completed the primary series of a CDC-approved COVID-19 vaccine and received a booster shot within the

recommended time period, I have not been exposed to someone with COVID-19 during the past 5 days.

- If I have been exposed to someone with COVID-19 between 5-10 days ago, and I am either (a) not vaccinated, or (b) I have not completed the primary series of a CDC-approved COVID-19 vaccine and received a booster shot within the recommended time period, and (c) I have not developed COVID-19 symptoms, then I will wear a mask at all times in the Business Meeting.
